The ARP authorizes \$39.6 billion in support to institutions of higher education to serve students and ensure learning continues during the COVID-19 pandemic.

WMed signed and returned to the U.S. Department of Education the Certification and Agreement for the CRRSAA and ARP with the assurance that the medical school will use the applicable amount of funds to provide Emergency Financial Aid Grants to Students. On February 3, 2021, the medical school was awarded \$39,282 from CRRSAA to use in support of students. On May 20, 2021, the medical school was awarded an additional \$107,319 from ARP.

As of this report, the medical school has not drawn down, or received any funds from CRRSAA or ARP. No monies from these programs have been disbursed to students. The medical school is reviewing the regulations to determine the best distribution of the funds to students. As of this report, 261 students are eligible to receive Emergency Financial Aid Grants under the CRRSAA and ARP programs.
